# WELCOME TO THE FAMILY: RSAM

On February 4, 2019 ACL completed the next step in its industry consolidation strategy with the acquisition of Rsam, an analyst-recognized leader in IT, vendor, and security risk management solutions, headquartered in Secaucus, New Jersey. The combination brought together ACL's true SaaS platform differentiated by its proprietary risk assurance

methodology, advanced analytics/robotic process automation, and top-rated user interface design with Rsam's dynamic flexibility, universal IT systems integration capability, and deep industry content. It also more than doubled ACL's R&D capacity, accelerating the delivery of innovation to 7,000 customers in 135 countries.

"This acquisition combines the strengths of ACL in delivering audit, compliance, and fraud related solutions, with those of Rsam in delivering vendor risk, IT risk, and cyber security solutions to enterprise IT and security customers," said Laurie Schultz, CEO of ACL. "The integration of our teams and platforms will transform our ability to provide a completely integrated and automated view of risk to the world's largest organizations—from front line operations to the board of directors—making our users the most sought-after professionals in their organizations."

#### **OUR NEW COMPANY:**



While we were very excited by the new possibilities offered by the combination of the two organizations, our old looks and names just weren't telling the new story as well as they could. So, it was time to shake things up and evolve our brand to better align it with our vision.

We chose the name Galvanize to carry the full story of ACL and Rsam into the future. It communicates the protection that our integrated governance software solution helps security, risk management, compliance, and audit professionals bring to their organizations.

#### What does Galvanize mean?

Galvanize has two meanings:

- + to shock or excite into taking action (i.e. as in helping trigger actions to manage risk performance)
- + to coat with a protective layer (i.e. as in protecting organizations from the negative impact of risks)

We wanted a name that captured who we are, what our platform delivers, and what we can do for the GRC industry.

Likewise, our new identity could no longer be carried by product acronyms. So we have renamed our integrated GRC platform to HighBond.

### What does HighBond mean?

HighBond captures our emphasis on bonding different risk, compliance, performance, and assurance solutions together in one view. Built by industry experts for industry experts, the HighBond platform unites risk management, compliance, security, and audit professionals around a single source of truth—the insight and automation to drive change.

No matter if the organization is managing threats, assessing risks, measuring controls, monitoring compliance, or expanding assurance coverage, HighBond automates manual tasks, blends organization-wide data, and broadcasts it in easy-to-share, actionable dashboards and reports.



# **UPDATE ON OUR GO-TO-MARKET STRATEGY**

With the merger of ACL and Rsam as Galvanize, the HighBond platform offers combined solutions that significantly expand our breadth of use cases from IT security and risk management to compliance and audit. By offering end-to-end governance, risk and compliance solutions, we can help our customers tackle all of their risk management needs. Our expanded portfolio of go-to-market products include the following Product Stacks:

**RiskBond:** Solutions for evaluating risks in the context of the organization's strategic objectives in an integrated platform - across the risk lifecycle of identification, assessment, quantification, treatment, and monitoring in order to enable optimal strategic achievement.

**ComplianceBond:** Solutions for tracking and mapping regulatory requirements against business processes and internal activities, automating testing for real-time compliance monitoring and reporting, and identifying and tracking remediation of issues.

**ControlsBond:** Solutions for centralizing and managing internal controls performance in support of standards, regulations, and business process requirements (e.g. SOX, COSO, COBIT, PCAOB ICFR and OMB A-123) across the control lifecycle of implementation, documentation, testing, issue tracking, remediation, reporting, and certification needs.

Highlights of the May '19 release include:


- + The launch of our HighBond platform and the completion of phase one of the integration between legacy ACL and Rsam products.

- + Improved workflow for managing the vendor on-boarding process, enhanced ability to monitor contracts and associated SLAs, expanded integration with third-party risk intelligence feeds to help customers better manage vendor risk exposure.
- + The ability to automatically trigger the appropriate response plan, depending on the nature of the crisis, as well as one-click reporting to quickly communicate results for our business continuity solution.

With the Spring '19 release in the hands of our customers, we are continuing to build out new features and enhancements for Fall '19 and beyond. To give you a sneak peak into what's coming next for HighBond over the next 12 to 24 months, we would like to highlight the following:

- + Natural language processing capabilities to help our customers intelligently link compliance, risks and controls content given their environment and industry
- + Automatically generated flow charts to allow users to easily visualize their business processes and map controls
- + Greater functionality for the front lines to foster collaboration between the 3-lines-of-defence
- + Solution for inter-related compliance requirements and updates to ease the pain of managing regulatory and compliance changes (i.e. optimizing compliance).





As our product Bonds are new for this release, we've included a visual representation of our Bonds that demonstrate our coverage of use cases from risk management to compliance to audit to IT governance and security.

Our near- and intermediate-term goals are to continue to expand our market share and diversify our business portfolio across the above solutions by geography and vertical. Galvanize's business is diverse by industry, effectively representing the same industry split as the S&P 500 with one notable exception being public sector.



#### PLATFORM-WIDE CHANGES


#### Legacy platform integration

We've completed our first phase of ACL and Rsam legacy product integration as HighBond, which includes three changes. From a technical standpoint, we've integrated user authentication for both ACL and Rsam legacy users by offering single-sign-on. From a customer perspective, we've centralized our login page so end users can access their HighBond products using a single authentication. Lastly and most importantly, we've integrated data sharing so data can be leveraged across both platforms for rich and executive ready storyboards to be built and shared.



#### **Improved UX in HighBond**

- + Email notifications. As users are frequently sent emails to inform or call to action, more often than not, critical 'call to action' items are missed. This is why we've redesigned emails that get sent to users from HighBond so they're more consistent, straightforward, and can't easily be missed so critical issues, tasks, and remediation items are completed timely.
- + User management. Managing user access for large organizations can be time consuming when a new team member needs to be added to 30 different projects. Users now have the ability to add users via groups (i.e. the "Compliance Group") using our 'group permissions' feature, which makes it easier to manage users across the enterprise.



#### **Improved UX in Rsam Bonds**

With this release, we've focused on improving the overall user experience in our Rsam Bonds products. A few of these changes include:

- + Report builder. What previously required customers to launch Visual Studio before even touching reports, we now have Microsoft Report Builder integrated with Rsam Bonds. This saves our users' time as that they can customize reports to their liking directly from the platform.


#### New cloud-only data processing and storage capabilities

As you may recall, organizations can run Robots either on the cloud or on-premise; the significant change this release is that customers can forego the on-premise part and completely run off cloud data sources. Since this removes the pain of needing to install and set-up a physical server, customers can deploy ACL Robotics quicker and start automating their data analytic activities right away.

#### **Robots enhancements**

We received great feedback from our early Robots adopters. We continue to enhance our automation capability to make it more usable and easy to use. Some great new capabilities we've introduced with this release are:

- + Easy debugging. Users can now view log files for each task directly in Robots to debug faster. Or, if preferred, customers can download individual log files from Robots for further analysis.
- + Better segregation of duties. We've added the ability to assign separate roles to users that are administrators in Robots. The new "Admin" role has ability to manage all Robots created while the "Manage Agent" admin role can only maintain the Agent. This helps separate the duties between data owners and IT colleagues who only need to maintain the Agent without the need to access sensitive information.
- + Enhanced ability to manage tasks. We added more flexibility for managing Tasks in Robots such as the option to cancel and/or delete an existing Task without the consequence of losing data.





#### **New data connectors**


Last year, we introduced unsupervised machine learning to Robotics with the CLUSTER command. This year, we've expanded on our machine learning capabilities with the introduction of supervised learning algorithms – the TRAIN and PREDICT commands.

#### **TRAIN and PREDICT**

TRAIN allows customers to train both classification (categories) and regression (numeric value) models using known values in existing data. These models can then be used by PREDICT to make predictions. The TRAIN command will automatically perform much of the data pre-processing, model selection, model tuning and cross validation that a data scientist would typically need to perform. Automating many of these steps reduces the complexities of creating a model, saving time and effort.

For further context on TRAIN classification and regression models, see below:

- + Classification (categories). Predict which of a set of categories a new record belongs to, based on the known categories of similar records. For instance if records have already been labeled as fraudulent or not, users can use that data to train a model that will automatically label new records as fraudulent or not.
- + Regression (numeric value). Predict a numeric value related to a new record, based on the known numeric values related to similar records. Regression can be used for risk assessments and risk modelling to name a few.


